

**MINUTES OF REGULAR MEETING OF THE  
RINCON VALLEY FIRE DISTRICT GOVERNING BOARD MEETING  
VIRTUAL AND IN-PERSON MEETING  
HELD November 21, 2024**

A public meeting of the Rincon Valley Fire District Governing Board was convened on **November 21, 2024, at 6:00 P.M.** The following members were Present at the meeting: Chairperson Jennifer Spears, and Clerk Kevin McKinley. Matt Messmer, Lora Gruner, and Chris Klasen attended virtually.

### B. 2025-021 - Fire Chief's Report – Reviewed by the Board. Report on file.

- We started our strategic planning process. We had two external sessions and three internal sessions. So far, we have developed five focus areas with corresponding goals and objectives about Service Delivery, Workforce, Sustainability, Training, & Community Outreach.
- Laura attended a three-day training in Glendale on FLSA rules & regulations.
- We have been busy with communicating with the accreditation peer team as they review our documents.
- Crews attended several public education events.
- Several program appraisals were attached to my report. The format for these is still under development.
- We had **49** new housing permits last month.
- We had **269** incidents and **103** transports.

### C. 2025-022 - October's Financial Reports—This meeting Reviewed, discussed, and possibly actioned the district's financial status, including monthly summary reports for October 2024. Gabe Buldra, with JVG, presented October's financial report.

#### Key points:

- Revenues for the month of October were \$919,240 which was \$793,984 under budget.
  - o Pima County revenue for October is \$782,085 which is \$844,097 under budget.
  - o Non-Tax Levy revenue for October is \$137,155 which is \$50,113 over budget.
- Expenses for the month of October were \$760,492 which was \$19,309 over budget.
- Fiscal year revenue is \$1,852,551 which is under budget by \$792,903 and 23% of the total annual budget.
- Fiscal year expense is \$2,374,494 which is under budget by \$229,911 and 32% of the total annual budget.

- Motion by Chairperson Spears, seconded by Member Gruner, to approve the monthly financial reports. The motion passed 5 to 0.


- We would like to formally recognize Matt Messmer for his service to the Rincon Valley Fire District.




